<u>Terms and Conditions for AirAsia Flights</u> <u>Social Media Contest Giveaway September 2024</u>

Introduction

- 1. This AirAsia Flights + Add-Ons Social Media Contest Giveaway September 2024 Social Media Contest Giveaway ("**Event**") is organised by AirAsia Berhad ("**Organiser**").
- 2. The Event will be held on AirAsia's Instagram account "flyairasia".
- This Event is governed by the terms and conditions set out hereunder ("Specific T&C") and the Event's General Terms and Conditions which can be found at <u>https://www.airasia.com/aa/about-us/en/gb/event-general-terms-and-conditions.html</u> ("General T&C").

Event Period

4. This Event will commence from 17:30 hour (GMT+8) on 27 September 2024, and end at 23:59 hour (GMT+8) on 4 October 2024 ("**Event Period**"). The Organiser reserves the right to amend or extend the Event Period at any time as it deems fit without prior notice and/or liability to any participant ("**Participants**").

Event Requirements

- 5. To qualify for and participate in this Event, Participants must fulfil all of the following requirements for the duration of the Event Period ("Event Requirements"):
 - a. must be at least eighteen (18) years old and possess valid identification documents;
 - b. must be a citizen of Malaysia and is located in Malaysia, as determined by the IP (Internet Protocol) geo-location detection on the Participants' Instagram accounts;
 - c. must have a valid and active Instagram account and with their Instagram profile set to 'public' for the duration of the Event Period; and
 - d. must adhere to the event mechanism as outlined hereunder.

Event Mechanism

- 6. When participating in the Event during the Event Period, the Participants must adhere to each of the steps outlined in the event mechanism below ("**Event Mechanism**"):

- iii. Participants must tag at least three (3) other Instagram accounts in the comment section.
- 7. Each Participant must successfully complete each of the three (3) steps outlined in the Event Mechanism above in order to qualify for one (1) valid entry to the Event.
- 8. Each Participant is allowed to submit only one (1) valid entry. Multiple comments by the same Participant will not increase their chances of winning. Only the first comment submitted will be considered as the valid entry.
- 9. Participants who fail to meet the Event Requirements and fail to fulfil the Event Mechanism will be disqualified from the Event, and Participants will be removed from consideration without notice and liability towards the Organiser.

10. There are two (2) prizes for this Event, which are as follows ("**Prize**"):

11. The Prize will be issued in the form of AirAsia's complimentary E-voucher with a fixed validity period of six (6) months and must be utilised before expiry of the validity period. For the avoidance of doubt, the validity period will commence six (6) months from the date of issuance of the E-voucher, which is the date it is received via email. The E-Voucher applies only to the base fare of the flights and excludes all other charges (such as relevant airport taxes and fees, insurance surcharge, service fees and baggage fees, travel insurance and any travel documentation charges and taxes). The Prize is also subjected to further terms and conditions as stated on the complimentary E-voucher.

Announcement of Winner

- 12. Subject to these Specific T&C, a total of two (2) Participants who meet the Event Requirements and strictly adhere to the Event Mechanism will be selected as the two (2) winners of this Event (collectively referred to as "Winners" and individually referred to as "Winner"), and each Winner will receive one Prize.
- 13. For clarity purposes, each Winner will receive two (2) return flights to any domestic destination in Malaysia.
- 14. The Winners will be announced via their Instagram handles in the comment section under the said Post on the @flyairasia Instagram account within five (5) working days after the end of the Event Period ("Winner Announcement Date"), together with the redemption instructions, *i.e.* Winners are required to furnish the Organiser with their personal details and email address for the purposes of issuance of E-Voucher by sending the required details through a "Direct Message" to @flyairasia Instagram account. Kindly note that only the individual named as the Winner in the said post is entitled to redeem and utilise the E-Voucher.
- 15. In the event the Winner is unreachable or fails to contact the Organiser to claim their Prize within five (5) working days after the Winner Announcement Date, the Organiser shall reserve the right at its sole discretion to automatically disqualify the Winner without any further notice and/or assigning any reasons. The Organiser's decision shall be final and no correspondence nor complaint by any Participant shall be entertained.

Miscellaneous

For avoidance of doubt, any other costs or expenses including but not limited to passports, visas, meals, hotel transfers, ground transportation, accommodation cost or any other personal expenses shall be borne by the respective Winner and the Organiser shall not be responsible for any costs or expenses incurred by the Winner in relation to the Event and the utilisation of the Prize.
- 17. AirAsia reserves the right at its sole discretion to cancel, terminate, or suspend the Prize with or without any prior notice and/or assigning any reason.
