

## **Terms and Conditions for VISA discount for AirAsia Flight 2024**

### **Introduction**

1. This VISA discount for AirAsia Flight 2024 (“**Event**”) is jointly organised by Move Travel Sdn. Bhd. (formerly known as AirAsia Com Travel Sdn. Bhd.) (Registration No: 201301020508 (1050338-A)) (“**Move**”) and Visa Worldwide Pte. Limited (“**Visa**”) (200719281K) (collectively referred to as the “**Organisers**”).
2. This Event runs concurrently in Malaysia, Singapore, Thailand, Indonesia and Philippines (collectively referred to as “**Participating Regions**”). The Event will be implemented on the AirAsia MOVE website at <https://www.airasia.com/en/gb> and AirAsia MOVE mobile application (collectively referred to as the “**Dedicated Platforms**”).
3. This Event is governed by the terms and conditions set out hereunder (“**Specific T&C**”) and the Event’s General Terms and Conditions which can be found at <https://www.airasia.com/aa/about-us/en/gb/event-general-terms-and-conditions.html> (“**General T&C**”).

### **Event Period**

4. This Event will commence from **00:00 (GMT+8) on 2 November 2024, and end at 23:59 (GMT+8) on 10 November 2024** or upon the complete utilisation of the total discounts on all the Eligible Products (as hereunder defined) in accordance with the total redemption allocation and daily redemption cap as specified in Table A, whichever comes first (“**Event Period**”).

### **Event Requirements**

5. For a person to qualify and participate in this Event (“**Participant(s)**”), Participants must fulfil the following requirements during the Event Period (“**Event Requirements**”):
  - (a) Must be a valid and existing AirAsia member (having subscribed and registered for membership under the loyalty and rewards program operated by BIGLIFE Sdn. Bhd. under the name “**AirAsia rewards**”) and have a unique registration number known as the “AirAsia member ID” issued by BIGLIFE Sdn. Bhd. at the point of participation in the Event. In the event the Participant is not a registered AirAsia member at the time of the Event, the Participant is required to sign-up as an AirAsia member via the Dedicated Platforms before participating in the Event. Any registration of AirAsia membership made after the Event Period shall disqualify the Participants from the Event and from receiving the entitlement;
  - (b) Must have a valid and existing Visa card issued by Visa, regardless of Visa credit or Visa debit card (“**Visa Card**”), for the purpose of purchase below;

- (c) Must be located in any of the Participating Regions based on the Internet Protocol geo-location detected; and
- (d) Must successfully complete all the Event Mechanism (as hereunder defined) during the Event Period.

**Event Mechanism**

- 6. Participants who adhere to the following event mechanism during the Event Period (“**Event Mechanism**”) are eligible to receive the corresponding discounts as tabulated below (“**Event Discount**”):
  - a. Participants must perform and complete the purchase of an AirAsia Flight booking with AK, QZ, Z2, FD and D7 flight codes (“**Eligible Products**”) for domestic and international travel through the Dedicated Platforms, with the travel period between 21 April 2025 to 28 March 2026 (both dates inclusive).
  - b. The purchase of the Eligible Products must be made with a Visa Card.
  - c. Purchase of the Eligible Products must be made in the currency in TABLE A with or without ancillaries (including but not limited to seats, meals and bags).
- 7. The Event Discount is awarded to the eligible Participant on a first-come-first-served basis, subject to a daily redemption cap, and a total allocation of 72,000 redemptions as tabulated in **TABLE A** below:

8. The daily redemption cap for the Event Discount will be refreshed everyday at 00:00 (GMT+8). For any given day during the Event Period, where the Event Discount is not fully redeemed, any remaining redemptions will be carried forward to the next day. The total redemption allocation represents the maximum number of redemptions during the Event Period.
9. Upon the insertion of the details of a valid Visa Card that is successfully registered as the payment method on the Dedicated Platforms during the Event Period, the Event Discount will be automatically reflected on the checkout page of the Dedicated Platforms.
10. The Participants may purchase the Eligible Products in multiple transactions and may be entitled to multiple redemptions of the Event Discount, subject to the daily redemption cap and total redemption allocation as specified in Table A above.
11. The Event Discount cannot be applied retrospectively to any past bookings on the Dedicated Platforms. Participants shall be responsible to ensure that the Event Discount has been successfully reflected on the checkout page before performing any purchase(s) and/or transaction(s) for the Eligible Products.
12. The Organisers are not obligated to issue the Event Discount should the Visa Card be rejected without assigning any reason whatsoever.

### **Miscellaneous**

13. The Participants acknowledge that Move's obligation is only limited to offering the Event Discount and as an operator of the Dedicated Platforms. The Participants acknowledge and agree that the purchase of the Eligible Product using their Visa Card shall be governed by the Visa's Terms and Conditions, where applicable.
14. In addition to the Specific T&C, the Participants are further subject to the terms and conditions of the Eligible Products which can be found on the Dedicated Platforms.
15. The General T&C may be amended from time to time, hence, you are advised to review it periodically to be aware of such modifications. In the event of any conflict or inconsistency between the Specific T&C and any terms and conditions set forth in the General T&C, the Specific T&C shall prevail.
16. The Specific T&C are governed by the laws of Malaysia and subjected to the jurisdiction of a forum in Malaysia.
