

Terms and Conditions for Members 100% Points Back Event

Introduction

1. This **Terms and Conditions for Members 100% Points Back Event** (“**Event**”) is organised by BIGLIFE Sdn. Bhd. (Registration No: 201001040731 (924656-U)) (“**BL**” or “**Organiser**”).
2. This Event concurrently runs in Malaysia, Thailand, Philippines, Singapore, Taiwan, China, Brunei, India, Vietnam, Australia, South Korea and United Arab Emirates (“**Participating Regions**”) and the Event will be implemented on AirAsia MOVE’s website (<https://www.airasia.com/en/gb>) and AirAsia MOVE mobile application (collectively referred to as “**Dedicated Platforms**”).
3. This Event is governed by the terms and conditions set out hereunder (“**Specific T&C**”) and the Event’s General Terms and Conditions which can be found at <https://www.airasia.com/aa/about-us/en/gb/event-general-terms-and-conditions.html> (“**General T&C**”).

Event Period

4. The Event will commence from **00:00 (GMT+8) on 1 June 2024**, and end at **23:59 (GMT+8) on 30 June 2024** (both dates inclusive) or upon complete utilisation of the total allocation of the Prize (hereunder defined) pursuant to this Event, whichever comes first (“**Event Period**”). The Organiser reserves the right to amend or extend the duration of the Campaign at any time as it deems fit without prior notice and/or liability to any participants (“**Participants**”).

Event Requirements

5. To qualify and participate in this Event, Participants must fulfil the following requirements during the Event Period (“**Event Requirements**”):-
 - a) must be a valid and existing AirAsia member (having subscribed and registered for membership under the loyalty and rewards program operated by BL under the name “AirAsia rewards Program”) and have a unique registration number known as the “AirAsia member ID” issued by BL at the point of participation in the Event. In the event the Participant is not a registered AirAsia member at the time of the Event Period, the Participant is required to sign-up as an AirAsia member via the Dedicated Platforms before participating in the Event. Any registration of AirAsia membership made after the Event Period shall not be entitled to the Prize under this Event;
 - b) must be located in the Participating Regions based on the Internet Protocol geo-location detection;

- c) must have a minimum balance of 10,000 AirAsia points in their AirAsia member account with any AirAsia points (any amount) that are expiring in the month of June 2024; and
- d) must successfully perform any of the transactions set out in the Event Mechanism (hereinafter defined) during the Event Period.

Event Mechanism

- 6. By participating in this Event, the Participants who adhere to the following event mechanism during the Event Period ("**Event Mechanism**") are eligible to receive the Prize:
 - (a) The Prize is awarded based on total AirAsia points used for redemption of **AirAsia Flight, Non-AirAsia Flight, AirAsia Hotel and AirAsia Ride only via the "Dedicated Platforms"**.
 - (b) For the avoidance of doubt, Participants who perform successful partial redemption will receive the Prize based only on the amount of AirAsia points used during redemption; the amount of cash top up used will not be taken into account.
- 7. There is no limit to the number of entries that Participants can make throughout the Event Period, and multiple entries can be entered in respect of the same Participant to be entitled for this Event's Prize.
- 8. Each Participant must successfully complete the Event Mechanism in order to constitute at least one (1) valid entry to the Event.

Prize

- 9. Participants who completed the Event Mechanism successfully will receive 100% Bonus AirAsia Pointsback ("**Bonus AirAsia Pointsback**" or "**Prize**") based on the total AirAsia points used for redemption of **AirAsia Flight, Non-AirAsia Flight, AirAsia Hotel and AirAsia Ride only via the "Dedicated Platforms"**.
- 10. Each eligible Participant is entitled to a **maximum of 10,000 Bonus AirAsia Pointsback** throughout the Event Period.

AirAsia points

- 11. The AirAsia points shall be awarded on a first-come-first-serve basis and subject to the availability of the total allocation of 15,000,000 Bonus AirAsia Pointsback under this Event.

12. Bonus AirAsia Pointsback earned through this Event will be credited into the eligible Participants' respective AirAsia member account within **thirty (30) working days** after end of the Event Period, subject to the Organiser receiving all information as deemed necessary. This is subject to the exclusion of invalid, cancelled or exchanged conversion and/or transactions, where no Bonus AirAsia Pointsback will be awarded to Participants pursuant to this Event.

Notwithstanding the standard validity period of AirAsia points as stipulated within the AirAsia rewards terms and conditions which can be found at www.airasia.com/rewards, the Bonus AirAsia Pointsback earned through this Event are only valid for a period of **one (1) month** from the date such Bonus AirAsia Pointsback are credited into the eligible Participant's AirAsia member account. Any Bonus AirAsia Pointsback not utilised within its validity period will lapse without notice or liability.

Miscellaneous

14. The General T&C may be amended from time to time, hence, you are advised to review it periodically to be aware of such modifications. In the event of any conflict or inconsistency between the Specific T&C and any terms and conditions set forth in the General T&C, the Specific T&C shall prevail.
15. The Specific T&C are governed by the laws of Malaysia and subjected to the jurisdiction of a forum in Malaysia.
